All Vendors/Organizations must provide a free chocolate treat (1 or 2 bite-sized) to everyone who stops by with one of our yellow maps. If you choose to do so, you may mark their map to ensure only one treat per person. Only 300 maps will be printed, so no more than 300 participants.

A health permit is not required for this event. However, it is recommended that treats be either:

- Individually packaged, or
- Served with gloves or waxed paper

We are partnering with the Pickerington-Violet Township Historical Society who will receive 50% of the event proceeds. Any maps not reserved in advance will be available the night of the event. Again, only 300 maps will be printed. You will need to supply your own table, chairs, etc. Also, depending on assigned location, you may need to bring a tent.
