**\*Food Vendors:** In addition to submitting this Application and fee, vendors serving/selling any type of food for human or animal consumption during a PVA-sponsored event are required to provide a Certificate of Insurance in an amount greater than or equal to \$1 million general liability insurance to cover the vendor's risks while at the PVA event.
